**Requirement:** Dogs must be proficient on all obstacles, this is a competition camp and remedial obstacle training will not be part of the curriculum. The exception to this are the camps listed as jumps and tunnels only. Dogs must be performing full coursework. Campers wanting a working spot must plan to attend all three days, no splitting/sharing of sessions will be allowed. Campers may work only one dog per session. If you want to work a second dog at the camp you must register for the lowest level of the dogs you plan to bring to not hold up an advanced group by working a less experienced dog on an exercise.

## Cancellation Policy

As much as we care about all our customers and their dogs, and we are extremely pained when we hear of either personal or canine tragedies, seminars are a business. We cannot keep running seminars if costs are greater than income and labor expended. We budget and hire instructors for seminars based on being able to fill an exact number of spots. The instructors and the facility don't care how many people ultimately attend camp – they charge us the same amount of money no matter what. We had to develop a cancellation policy that takes this into consideration and that treats everyone equally. We do not make exceptions to this policy as it is impossible to judge whether one person's emergency is more important and more deserving of a refund or credit than the next person's. We do the best we can to maintain an active waiting list, but we cannot guarantee that there will be a waiting list if you must cancel. It is critical that you read the following information carefully as there are NO exceptions to our cancellation policy other than being called to active military duty.

**Before October 15th:** All fees will be refunded except for the \$200 non-refundable deposit.

**October 15th to November 15th:** 50% of the total fees paid will be refunded except for the

\$200 non-refundable deposit. **November 15th to the start of camp:** 50% of the total fees paid will be refunded **ONLY IF YOUR SPOT CAN BE FILLED** except for the \$200 non-refundable deposit.

**CANCELLATION POLICY -- I have read the above cancellation policy and I agree to all terms. I understand that there are NO EXCEPTIONS to the policy regardless of the reason that I cancel my Camp reservation.**
